- Reclassification Rates
  - FSUSD rate of reclassification
     (14.3%) exceeds the statewide rate
     (13.8%)
  - Dual Immersion rate of reclassification was 14.9%
- Percentage of students At-risk of becoming Long-term English Learners (LTELs) decreased from 18.7% to 13.9%
- Percentage of LTELs decreased from 18.9% to 11.8%




#### English Learner Program Opportunities for Growth
